We must stress that whilst Willows provides staff on certain activities to ensure they are being used correctly, all children remain the responsibility of the Group Leader and must be supervised at all times.

Compliance with the Code of Practice for visitor attractions. • All animals on site are hand-picked for their docile nature. • Group Leaders must ensure that children wash their hands after handling or feeding the animals and before eating or drinking. • Please DO NOT use gels or wipes instead of washing hands with soap and water. There are plenty of hand washing facilities on site. Hands MUST be washed with running water and soap and dried with paper towels. Appropriate signage is displayed. Training given to staff. • Use of appropriate disinfectants throughout the animal areas. Regular inspection by vets. • Regular cleaning regimes in place for all animal enclosures. • Wash your hands thoroughly at home with soap and water after removing dirty clothes, shoes or boots that have been worn at Willows Activity Farm. Any soiled clothes should be washed immediately on your return home.

Animal Feeding	Infection Biting	Children Parents Guardians Carers Teachers Members of the Public	Low	<ul style="list-style-type: none"> • Feeding of animals is only permitted in our designated animal feeding areas. • Double fencing in non-contact areas so there is no direct or indirect contact with livestock. • In all contact areas there is hand washing facilities and signage displayed • Group Leaders can choose to by-pass these areas if they wish. Animal feed should not be tasted. • Group Leaders must ensure that children wash their hands after handling or feeding the animals, touching animal fences and before eating or drinking. Please DO NOT use gels or wipes instead of washing hands with soap and water. There is plenty of hand washing facilities on site. Hands MUST be washed with running water and soap and dried with paper towels. • We also advise no contact with sheep, lambs, goats and kids if you are pregnant or think you are pregnant as this is a risk to adult females • Wash your hands thoroughly at home with soap and water after removing dirty clothes, shoes or boots that have been worn at the Willows Activity Farm. Any soiled clothes should be washed immediately on your return home.

It is up to the Group Leaders if you wish to take part in this activity. Group Leaders must ensure that children wash their hands after handling or feeding the animals, touching animal fences and before eating or drinking. Please DO NOT use gels or wipes instead of washing hands with soap and water. There is plenty of hand washing facilities on site. Hands MUST be washed with running water and soap and dried with paper towels. The higher risk animal groups being baby calves, lambs and piglets are not used for animal handling sessions. We also advise no contact with sheep, lambs, goats and kids if you are pregnant or think you are pregnant as this is a risk to adult females. Wash your hands thoroughly at home with soap and water after removing dirty clothes, shoes or boots that have been worn at the Willows Activity Farm. Any soiled clothes should be washed immediately on your return home.

Training manuals – trained staff only to supervise equipment. Group Leaders must ensure that children wash their hands after playing in play areas and on play equipment and before eating or drinking. Please DO NOT use gels or wipes instead of washing hands with soap and water. There is plenty of hand washing facilities on site. Hands MUST be washed with running water and soap and dried with paper

Rides are fenced off and can only be accessed through a staffed gate. • All rides regularly maintained and tested as part of a recognized national accreditation scheme. • Supplier maintained, test and certified RCD and trip switches. • This activity is checked daily and the results recorded.

Willows Activity Farm has a Lost Child Policy.
Uneven Surfaces	Slip/Trip/Fall	Children Parents Guardians Carers Teachers Members of the Public	Low	<ul style="list-style-type: none"> • Changes in level highlighted with yellow paint etc. where significant risk of trips. • Maintenance of floor surfaces, including potholes. – particularly in pedestrian areas. • Group Leaders and children should take care when walking and wear sensible footwear. • Children should be instructed not to run whilst on site. • Appropriate signage displayed where possible. • Group leaders remain fully responsible for the children at all times

Snow Icy conditions Adverse Weather (extreme heat and cold)	Slip/Trip/Fall Risk of ill health Examples: Hypothermia, Sunburn, dehydration Fainting	Children Parents Guardians Carers Teachers Members of the Public	Low	<ul style="list-style-type: none"> • Salt or grit in icy conditions in main pedestrian walkways. • Farm Park staff regularly inspect the site to identify hazards and risks. • Some play equipment or attractions may be closed for safety reasons. • Group leaders are responsible for ensuring adequate provisions are provided for children. • Ensure adequate hydration is maintained. • Sun block advised in warmer weather. • Non-slip footwear is advised.
Wet Grass Wet Ground	Slip/Trip/Fall	Children Parents Guardians Carers Teachers Members of the Public	Low	<ul style="list-style-type: none"> • Group Leaders and children should be aware of the possibility of wet grass and take adequate precautions.
